Biographies

Panelists



RADM (Ret.) Kenneth Moritsugu is the President and Chief Executive Officer of First Samurai Consulting, LLC, a firm specializing in health consulting focused on public health systems and policies, “putting the patient at the center of everything we do.”

RADM (Ret.) Moritsugu was the Acting Surgeon General of the United States, in 2002 and again from July 2006 until his retirement from the Commissioned Corps of the United States Public Health Service (USPHS) in September 2007. As Acting Surgeon General, he served as the nation’s top doctor, communicating the best available science and information to the American people to help protect, promote, and advance their health and safety. He was the operational commander of the 6,500 Commissioned Corps health professionals. A career officer in the USPHS for 37 years, he served as the Deputy Surgeon General of the United States from 1998. In these roles, he was responsible for the development and issuance of twenty major

documents from the Office of the Surgeon General of the United States, including the landmark Surgeon General’s Report on Mental Health.

Other key HHS and government positions in which RADM (ret.) Moritsugu served include the Director of the Division of Medicine, Deputy Director of the Bureau of Health Professions, Director of the National Health Service Corps, and Assistant Bureau Director for Health Services and Medical Director of the Federal Bureau of Prisons.

From 2007, Dr. Moritsugu was the Vice President for Global Professional Education and Strategic Relations for Johnson & Johnson’s Diabetes Solutions Companies, and former WorldWide Chairman of the Johnson & Johnson Diabetes Institutes (JJDI). He retired from Johnson & Johnson in 2013.

Most recently, Dr. Moritsugu served as the Interim Chief Science and Medical Officer of the American Diabetes Association from August 2019 through June 2020. In that role, he was responsible for the generation of the annual Standards of Medical Care in Diabetes, as well as the production and conduct of the 80th Annual Scientific Session of the ADA, the first-ever virtual production of this global meeting. During his tenure, the ADA provided guidance regarding COVID-19 and its impact on people with diabetes, underwent an internal realignment of its science and medicine activities, and refocused its mission.



RADM (Ret.) Scott Giberson is a uniquely experienced public health leader. After nearly 27-years, he retired as a two-star Admiral and as an Assistant U.S. Surgeon General for 11 years. He has worked extensively with indigenous populations around the world and is well versed in the delivery of healthcare solutions in under-resourced and vulnerable populations. RADM (ret.) Giberson held leadership roles within the Department of Health and Human Services, Department of Homeland Security, and the Department of Defense and has successfully led organizations and agencies through global and domestic health crises. At AMI, he continues to provide overall leadership, management, and strategy for AMI, provide clinical and public health solutions and expertise, and

fosters global client relations at the highest levels. Clients include senior leadership of the WHO, UN, multiple U.S. and foreign government entities, and private industry partners.

Prior to AMI, RADM (ret.) Giberson served in many leadership roles including the acting Deputy Surgeon General of the United States (2013-2014), where he worked with the U.S. Surgeon General to develop and deliver scientific information to the public to improve the health of the Nation including release of the 32nd Report on Tobacco Use and the National Prevention Strategy. He was the principal liaison with leadership in DOD, DHS, DOJ and HHS. He held executive positions as the Senior Advisor to the Surgeon General, Director of Commissioned Corps Headquarters, and Senior Public Health Advisor for Pacific Command's Center of Excellence in Disaster Management and Humanitarian Assistance, helping to lead the President's Emergency Plan for AIDS Relief (PEPFAR) implementation for the DOD across multiple Asia-Pacific and African countries. During his leadership roles, he developed and authored many national strategies and transformed multiple health programs and agencies. He also served as overall Commander of the Commissioned Corps' Ebola Response in West Africa where he provided oversight of multiple missions and deployment of over 1,000 medical and public health officers.

For the first 10 years of his career, he worked in several Indian Health Service (IHS) medical centers where he was credentialed and privileged for clinical roles both in the pharmacy and as a mid-level provider in family medicine. He was also the Director of the IHS National HIV/AIDS Program where he catalyzed an increase in both opt-out and prenatal HIV screening nationwide.

RADM (ret.) Giberson has authored numerous articles and delivered well over 100 keynote lectures on leadership, global health, and public health (and 15 university Commencements) at numerous venues domestically and internationally. He has been interviewed on multiple TV and radio affiliates including ABC, MSNBC, and CNN and serves on several academic boards. RADM (ret.) Giberson has received numerous service awards including the Defense Meritorious Service Medal, the Surgeon General's Medallion, and USAID's Humanitarian Group Award. In 2015, he received the Presidential Unit Citation from President Obama in the Oval Office for leadership during the West African Ebola response.

He is a graduate of Temple and U. of Massachusetts/Amherst, holds a BSPHarm, MPH, and graduate certificate in Health Emergencies in Large Populations. He has received three honorary Doctoral degrees and is a Fellow of a Wharton School Executive Leadership Program. In 2018, the Military Officers Association of America selected him as one of the "Top 100 Veterans in the Last 100 Hundred Years You Need to Know".



RADM (Ret.) Robin M. Ikeda is a public health professional/leader with 30 years of experience at the state and federal level, including several years in executive leadership positions at the Centers for Disease Control and Prevention (CDC). Dr. Ikeda currently serves as CDC Associate Director for Policy and Strategy, where she directs and oversees agency policy, performance, evaluation, and strategy-related efforts. She previously served as CDC Deputy Director for Non-Infectious Disease (2010-2019). In this role, she oversaw the four non-infectious disease Centers (injury prevention, chronic disease, environmental health, birth defects/developmental disability), with a combined total portfolio of \$1.5 billion and 3,000 employees. Dr. Ikeda began her public health career as a CDC Epidemic Intelligence Service Officer assigned to the Bureau of Communicable Disease Control at the New York State Department of Health in Albany, New York.

Dr. Ikeda holds a B.A. from Stanford University, an M.D. from Cornell University Medical College, and an M.P.H. (Epidemiology) from the Emory University Rollins School of Public Health. She is board-certified in Internal Medicine and retired from the US Public Health Service in 2020. Dr. Ikeda lives in

Atlanta with her husband and has two adult daughters. Outside of work, she enjoys spending time with her family, reading, hiking, and skiing.



RADM David P. Goldman has joined FDA's Office of Food Policy and Response as Chief Medical Officer effective January 15, 2019.

As Chief Medical Officer for the foods program, Dr. Goldman will play a pivotal role in continuing to advance the agency's work to improve our recall efforts. Dr. Goldman's work will also include the full portfolio of work previously led by the Center for Food Safety and Applied Nutrition's (CFSAN) Chief Medical Officer. This includes providing leadership to foods program medical officers and chairing CFSAN's Health Hazard Evaluation Board, which evaluates the human health effects of physical, microbiological, chemical, or radiological contamination of food and cosmetic products.

Dr. Goldman most recently served as the Chief Medical Officer of the Food Safety and Inspection Service (FSIS), which is part of the USDA. In this role, he was responsible for occupational health issues related to chemical and biological exposures, as well as providing medical expertise on emerging food safety issues. He was previously Assistant Administrator for FSIS's Office of Public Health Science from November 2004 through May 2018, leading a staff of 300 that provided the scientific foundation for FSIS policies, conducted microbial risk assessments, and executed a national sampling program of meat and poultry products. In addition, at the appointment of the U.S. Surgeon General, Dr. Goldman served as the U.S. Public Health Service (USPHS) Chief Professional Officer for physicians from 2013 to 2017.

Dr. Goldman is a board-certified family medicine and preventive medicine/public health physician, and a member of the Commissioned Corps of the U.S. Public Health Service since February 2002. He spent 10 years in the U.S. Army Medical Corps, practicing both family medicine and preventive medicine. He then spent 3 ½ years at the Virginia Department of Health, first as a District Health Director, then briefly as the Deputy State Epidemiologist, before joining the USPHS and FSIS. Dr. Goldman received his Bachelor of Arts from the University of Virginia, his Doctor of Medicine from the University of Virginia. He holds a Master of Public Health in Epidemiology from the University of Washington.



CAPT Marivic Fields is a social worker with the United States Public Health Service (USPHS). She currently holds the position of a Senior Advisor for Child Well-being and Safety in Office of Refugee Resettlement within the Administration of Children and Families (ACF). Prior to this assignment, she was a Public Health Officer in the Community Mental Health Services in Substance Abuse and Mental Health Administration (SAMHSA), where she worked with state planners in the development of a comprehensive mental health programs for adults with severe mental illness and children with severe emotional disability.

Prior to transferring to USPHS, CAPT Fields was a social worker with the U.S. Army Reserve, and she was deployed to Iraq and mobilized to active duty where she served as Chief of Social Work Services/Family Advocacy Unit and Director for Patient Care Management. She has extensive experience in clinical care of military service members and family members and provided case management of high-risk behavioral health patients in the military treatment facility.

CAPT Fields has many years of experience in child welfare and worked as a line social worker and supervisor for Child Protective Services in San Diego County, California. She holds a B.S. degree in Psychology and a master's

degree in Counseling Psychology from National University in Irvine, California, Master's in Social Work from San Diego State University and recently completed in June 2020 a Master's Degree in Defense and Strategic Studies at the U.S. Naval War College.



CAPT Josef F. Rivero serves as a Senior Health Service Officer currently assigned to the National Institutes of Health (NIH) in Bethesda, Maryland. He is a Physician Assistant and a clinical research trial associate investigator in the National Heart, Lung and Blood (NHLBI) Institute. He provides direct clinical management of phase II clinical trial patients in bone marrow transplant and gene therapy protocols. Recently, he was recruited as one of the Associate Investigator in the Fostamatinib for the Treatment of Hospitalized Adults with Covid-19. As proven leader, he served as a NP/PA Sig group MEC Representative from 2018-2020. He is an active-duty member of the Commissioned Corps of the U.S. Public Health Service since 2008. CAPT Rivero's recent deployment in the Commissioned Corps includes serving as the Deputy Officer-In-Charge of the 2021 Unaccompanied Children mission "USPHS Operation Artemis and Chief of Operation of the NIH Covid-19 Vaccine Operation from December 2020 to May 2021. He was selected as the lead clinical specialist for the 2020 Covid-19 Japan Response in which he was awarded the PHS Meritorious Service medal. CAPT Rivero's other deployments include 2014 Epidemic Ebola Response in Liberia, Africa, 2010 Haiti Earthquake, and 2005 Operation Iraqi Freedom.

CAPT Rivero held various leadership positions in both local and national Commissioned Officers Association of the USPHS organizations. He served as Commissioned Officers Association Board of Directors for term 2014-2016 and currently the Chair of the National COA Local Branch Committee for 2015-2016. CAPT Rivero served as the Chair of the Health Services Professional Advisory Committee (HSPAC) in 2017 overseeing over 1300 health service officers. Prior to his HSPAC chairmanship, CAPT Rivero held numerous subcommittee leadership roles to include chair of the HSPAC Recruitment and Retention, Policy, and membership subcommittees.

CAPT Rivero attended Medical University of South Carolina and earned his first Bachelor of Science in Medical Technology in 1991. In 1996 he completed his second Bachelor of Science in Physician Assistant from the Medical College of Georgia, Augusta Georgia. In 1998, CAPT Rivero completed an emergency fellowship with West Virginia University and Alderson Broaddus University concluded with Master of Science in Medical Science. In May 2021, CAPT Rivero successfully completed his Master of Applied Science in Patient Safety and Health Care Quality at Johns Hopkins Bloomberg School of Public Health.



CAPT Helen Saccone serves as a Senior Advisor within CDER's Office of Strategic Programs (OSP). CAPT Saccone was part of the inaugural team that initiated the US-EU Mutual Reliance Initiative in 2014, that led the negotiations and implementation of the US-EU Mutual Recognition Agreement for the FDA. Since joining OSP in 2018, she has been focused on developing and implementing a Cloud-based data lake with analytics capabilities to integrate dissipated internal and external data sources and facilitate real-time, data-based decision making and response to public health emergencies.

CAPT Saccone joined FDA in 2008 as a Program Management Officer within CDER's Office of Compliance, then served as the Associate Director of Global Policy within FDA's Office of Commissioner. Prior to joining FDA, she worked as a pharmacy inspector for the DC Department of Health and a Senior Manager of Education at the American Pharmacists Association.

CAPT Saccone received her Doctor of Pharmacy from Rutgers University and was commissioned into the US Public Health Service in 2009.



Mr. Jeff Nelligan is a Public Affairs Associate in the FDA Office of Global Policy and Strategy, D.C. Prior to this post, he worked for three Members of the U.S. Congress and was a senior executive at GAO; was twice a Schedule C Presidential Appointee serving senior Cabinet officials in the Departments of State and Health and Human Services; operated as an advance man on numerous Congressional, Presidential, and national advocacy campaigns. He is a 14-year veteran of the U.S. Army Reserve, rising to the rank of corporal. He is of Polynesian ancestry - Maori Indian - and is a graduate of Williams College, Georgetown University Law School, the U.S. Army Air Assault School, and the French Army Brevet Commando School. He is the author of six books, including *Four Lessons From My Three Sons: How You Can Raise a Resilient Kid*; *Tales From the Swamp: Five Habits of Successful Politicians – Notes of a Fixer*; and his Ph.D thesis for Faber College is entitled *Be the Ball, An Academic Inquiry Into Synergistic Character Modalities in Caddyshack*.

He is the father of three sons; the two eldest are graduates of the U.S. Naval Academy and Williams College and the youngest is a senior at West Point.



Dr. Wendy R. Sanhai has extensive experience across a broad spectrum of issues in the pharmaceutical, biotech and medical device industries and regulatory science. Over the course of her career, she has held key leadership roles in academia, at federal research and regulatory organizations including the NIH, the Foundation for NIH (FNIH) and the FDA and, most recently, within private industry. Among her many strengths is her ability to identify critical governance, strategic and scientific gaps, and leverage resources to create innovative approaches in support of large-scale, strategic, scientific, and public health initiatives, all directed to patient benefit. Her experiences include developing strategies for governance, research, business development, as well as the design, implementation, and management of large-scale scientific collaborations at the NIH, FNIH, FDA, academia and industry. She has worked across multiple therapeutic and disease prevention areas as well as in medical product development, addressing specific product development issues,

regulatory challenges as well as global health needs.

Dr. Sanhai's dedication to the advancement of biomedical research and public health began in academia while serving first as *Clinical Chemistry Fellow*, then *scientific researcher*, and ultimately a *faculty member* in the Departments of Pathology and Medical and Research Technology at the University of Maryland, School of Medicine. She left academia in 2001 to join the NIH, Office of Technology Transfer as a *Technology Licensing Specialist and Patent Advisor*, where she managed a license and intellectual property portfolio of more than 300 NIH invention families from across 27 Institutes and Centers of the NIH, with special emphasis on the National Cancer Institute.

Dr. Sanhai joined the FNIH in 2002 as *Director of Public-Private Partnerships*. In this position, she created, implemented, managed, and evaluated all new and existing programs in clinical research, education, and training. In 2004, Dr. Sanhai was appointed *Senior Scientific Advisor, Office of the Commissioner, FDA*, where she led until 2011, the development, implementation, and management of FDA's Scientific Initiatives and Strategic Partnerships as part of FDA's public health mission.

Following her 10+ years within the Department of Health and Human Services, Dr. Sanhai joined GlaxoSmithKline (GSK) in 2011 as *Senior Director, Regulatory Policy and Advocacy*. In this capacity, she was responsible for ensuring that GSK remained current on the continually evolving regulatory environment and, most importantly, retained a leadership role in efforts to adapt to new science/medicine, changes in healthcare policy, and changes in the macro political and economic environment. Entering the consulting world in 2014, Dr. Sanhai served as *Senior Managing Scientist* at Exponent Inc., an international consulting firm with over 90 scientific and engineering disciplines. In 2016 she joined Deloitte Consulting: Federal Strategy and Operations as a *Specialist Leader*.

Dr. Sanhai received a Ph.D. in clinical biochemistry and structural biology from the School of Medicine, State University of New York at Buffalo, an Executive M.B.A., Smith School of Business, and a baccalaureate degree in chemistry from the University of Florida, Gainesville.

Master of Ceremony



CDR David Shih is a preventive medicine physician serving as a medical epidemiologist in the CDC's Division of Global Health Protection within the Center for Global Health.

He completed a medicine internship at MetroHealth Medical Center in Cleveland and preventive medicine residency at the University of Maryland, where he earned a Master's degree in epidemiology and preventive medicine. He began his federal career as a civil servant at the Food and Drug Administration as a drug safety epidemiologist in 2010 then commissioned in the U.S. Public Health Service in 2013. The next year, he deployed to Liberia to care for suspect, probable, and confirmed Ebola patients in the Monrovia Medical Unit, the U.S. Government's only Ebola treatment unit in West Africa at the time. In 2016, he joined the Epidemic Intelligence Service (EIS) as a field EIS officer for the Oregon Health Authority's Acute and Communicable Disease Prevention Section.

There, he led a successful effort to develop a Council of State and Territorial Epidemiologists surveillance case definition for nontuberculous Mycobacterial infection. In 2018, he relocated to Virginia to work at the Defense Health Agency as epidemiologist and Chief Medical Officer for Population Health. In May 2021 the American College of Preventive Medicine awarded him the Distinguished Federal Preventive Medicine Medical Officer

Award. In his current CDC role, he provides other countries technical assistance in developing acute febrile illness surveillance systems, especially to leverage resources to improve COVID-19 surveillance. CDR Shih bicycles in his spare time. In 2015 he accepted a physical fitness challenge from then-Deputy Surgeon General RADM Boris Lushniak, joining 32 other USPHS officers in 2015's Register's Annual Great Bicycle Ride Across Iowa. CDR Shih also sings baritone in the USPHS Music Ensemble and cites, as the highlight of his career, an *a capella* solo in Ukrainian at RADM Lushniak's 2015 retirement ceremony concert.

Speakers/Moderators



CDR Trang Tran is the 2021 APAOC Chair. She currently serves as a Senior Regulatory Health Project Manager in the Office of New Drugs within FDA, overseeing the review and approval processes for nonprescription drug applications and the administrative order process for sunscreen products. She is also managing the development and clearance of guidances for industry for the implementation of the first Over-The-Counter (OTC) Monograph User Fee Program to modernize the OTC drug review and OTC monograph drug development process. Prior to this position, CDR Tran served as the Policy Project Manager for the Office of Generic Drug Policy within the Office of Generic Drugs, overseeing the development, clearance, and implementation process for various FDA's priority regulatory policy documents and special projects. She was the Lead Project Manager for the first Generic Drug User Fee Amendments (GDUFA) policy implementation and the strategic planning for the GDUFA reauthorization negotiations with generic pharmaceutical industry.

Prior to serving as the Policy Project Manager, CDR Tran was the Senior Regulatory Project Manager in the Office of Generic Drugs, coordinating over 160 generic drug approvals with 26 being the first generics.

CDR Tran received her Doctor of Pharmacy Degree from Temple University - School of Pharmacy. She completed the pharmacy residency at the University of California, San Diego - Medical Center and the Executive MBA at the University of Maryland, Robert H. Smith School of Business.



CDR Quynh-Van Tran is the current Co-Chair of APAOC Education and Training Subcommittee. She currently serves as a team leader in the Good Clinical Practice Compliance Oversight Branch in the Office of Scientific Investigations at the Food and Drug Administration (FDA). In this role, she leads a team of reviewers whose primary responsibilities are to evaluate complaints regarding clinical investigators, sponsors, institutional review boards, and contract research organizations and issue for-cause inspection assignments. Under her leadership, her team has evaluated over 1300 complaints of significant public health concerns and issued over 150 inspections to follow up on allegations of clinical trial misconduct involving safety of patients enrolled in clinical studies (e.g., data falsification, enrollment of ineligible subjects, failure to report serious adverse events or deaths, and overdose/underdose of investigational drug, resulting in patient harm).

CDR Tran held various leadership positions, including District of Columbia Commissioned Officers Association (DC COA) President (2020-2022), DC COA President-Elect (2019-2020), DC COA Treasurer (2014-2016) and DC COA Finance Chair (2013-2014). In addition to her leadership roles in DC COA, she served the Resource Coordination Branch Chief on the Tier 1 deployment team (RIST-NCR) from 2019-2021 and participated in

several deployments to support the USPHS mission: Ebola (2015); Peace Officer Memorial (2017); Independent Day Celebration (2017); Hurricane Harvey and Irma (2017), State of the Union (2018), United Nations General Assembly (2019); COVID-19 Healthcare Resilience Working Group (2020); and FDA COVID-19 Vaccine Clinic (2021).

CDR Tran received her Bachelor of Arts degrees in biology and psychology from the University of Virginia and her Doctor of Pharmacy degree from Virginia Commonwealth University/Medical College of Virginia, School of Pharmacy. She also completed a residency in Psychiatric Pharmacy Practice from University of Maryland, School of Pharmacy and is board-certified in Psychiatric Pharmacy Practice.



LCDR Ruby Leong has been an active member of APAOC as both a volunteer and voting member since her commission in 2017 and is currently enthusiastically serving her term as the APAOC Chair-Elect. LCDR Leong is stationed in Silver Spring MD at the Food and Drug Administration as a Clinical Pharmacology Team Lead in the Division of Cancer Pharmacology responsible for approval of safe and effective oncology/hematology new drugs. She is a board-certified oncology pharmacist. LCDR Leong received a Doctor of Pharmacy from the University of Michigan and completed a postdoctoral fellowship in oncology drug development at Rutgers University/Hoffmann-La Roche.



LCDR Sophia Park serves as a Program Coordinator in the Division of User Fee Management in CDER's Office of Management within FDA, where she reviews requests for waivers, exemptions, and refunds of prescription drug user fees assessed under the Food, Drug, and Cosmetic Act. These various waivers or reduction in user fees are granted for certain orphan drug products, drugs that protect the public health, and innovative drug products where the fee would present a significant barrier due to limited resources. Previously, LCDR Park served as a Consumer Safety Officer in the Compounding Incidents Team within CDER's Office of Compliance where she investigated adverse events associated with compounded drug products and coordinated appropriate regulatory actions. Prior to FDA, she worked as a clinical pharmacist at the Acoma-Canoncito-Laguna Service Unit, Indian Health Service.

LCDR Park received her Doctor of Pharmacy Degree from University of Maryland, School of Pharmacy and was commissioned into the U.S. Public Health Service in 2012.
